6. Participation policy and disclaimer and acceptance of risk

I understand that the FJFNB and their representatives will take all necessary precautions to see to the well-being and safety of each participant. However, I am aware that the FJFNB, their funders, staff, chaperones, agents, and volunteers assume no responsibility for any injury, loss, damage, or harm caused to any participant or his property during the activities that are held as part of the event, or during the stay and the trip there and back.

I understand and accept that participation in the event may involve certain risks such as injury, loss, damage or harm and I agree to indemnify and release the FJFNB, its funders, staff, chaperones, agents and volunteers from any injury, loss, damage or harm that the participant may suffer as a result of participating in the event, UNLESS the injury, loss, damage or harm has been caused by the SOLE NEGLIGENCE of the FJFNB or their staff in the performance of their duties.

I declare that my child has read and agrees to abide by the participation policies for the entire duration of the event, as well as during transportation (to and from the event), the laws in force in the province of New Brunswick and the federal laws.

Participation policies:

- Alcohol, drugs, tobacco: No consumption or possession of these substance will be tolerated for the total duration of the event as well as during the transport (round trip);
- Harassment and intimidation, no form of harassment or intimidation whether physical, verbal or virtual, will be tolerated for the duration of the event. FJFNB events are safe spaces.
- Presence: the participant agrees to be present at all activities and meetings for the entire duration of the event. No one may leave or be absent from the event site without the express permission of a FJFNB staff member.

Sanction committee: A sanction committee will be formed for the duration of the event. This committee will be responsible for evaluating cases of non-compliance with participation policies and imposing sanctions (loss of participation privileges, refusal of entry during social activities, immediate dismissal from the activity at the expense of the participant and/or parent/guardian).

In the event of illness, or non-compliance with rules, parents/guardians will be required to pick up their child at the venue.
